**Explanatory Notes** 

This Certificate of Identity form can <u>only</u> be used for the purpose of providing supporting documentation as part of an application for a driving licence or learner permit and should not be used for any other purpose.

#### This Certificate of Identity form should only be used in the following circumstances:

✓ You do not have an Irish driving licence or learner permit to submit with your application (because either you are a first time applicant or because having held an Irish licence or learner permit, it has been lost, stolen or destroyed and declared as such)

#### **AND**

✓ You hold an Irish or UK birth/adoption certificate

#### **AND**

✓ You do not have a Public Services Card

#### AND

- ✓ You have never held a passport OR
- ✓ Your Irish passport has expired by more than 12 months OR
- ✓ You have lost your passport OR
- ✓ You do not have a valid UK photo licence.

When completing the form, please write clearly using a black ballpoint pen.

This form should be signed in the presence of, and witnessed by, a Medical Doctor, Solicitor, Commissioner of Oaths, Bank Manager, School Principal or Elected Public Representative.

The witness must have known you personally for at least the last 2 years and must not be related to you in any way. The witness must complete section 2 of the form in full.

The photograph should be attached in the box provided using staples or gum/glue before calling to the Doctor, Solicitor, Commissioner of Oaths, Bank Manager, School Principal or Elected Representative (please do not obstruct the face with a staple when attaching the photograph).
